# Accountancy at Massey University

Accountancy is one of the most popular areas of study within Massey Business School. A degree in accountancy offers graduates a number of employment opportunities, leading to interesting and satisfying careers in many different areas including:

- chartered accounting (audit, tax, business services, consulting)
- business (financial accounting, management accounting, financial, management)
- finance
- banking
- the public sector

For example, an accounting career often begins in a chartered accountancy firm. After completing a professional qualification (such as CA, CPA, ACCA or CMA) and gaining experience, it is common for accountants to move to accounting positions in business, and from there go into management. Alternatively, accountants who stay with accounting firms are likely to develop specialised areas of expertise and become involved in consulting.

With many professional accreditations, the School of Accountancy is one of only two institutions in New Zealand and Australia awarded the prestigious AACSB International accreditation. Only twelve other institutions outside the USA have achieved this distinction.

## 2+2 Pathway Programme

### COMPONENTS:

- Two (2) years SDUFE Auditing and Accounting Programme\*
- Two (2) years at Massey University, Bachelor of Business (Accountancy)\*\*

Upon successful completion of all four (4) years, students will be eligible to graduate with a Bachelor of Business majoring in Accountancy.

\*Students must complete the following SDUFE courses 16200011, 16200021, 16200031, 07200011, 08300011, 03200011, 01200011, 01200021, 16200041, 08300041.

\*\*To enter Massey's Bachelor of Business (Accountancy), students must have achieved:

- IELTS score of 6.0 (minimum 5.5 in each band) or equivalent
- Minimum GPA of 5.0 (70% or B) during the first two years of study at SDUFE

Students can commence their study in Semester One (February start) or Semester Two (July start), at either the Auckland or Manawatū campus.

## Bachelor of Business (BBus) Accountancy Major

During the next two years at Massey, students will study the following schedule of courses (totalling 240 credits).

### ELECTIVES (75 credits):

- 100-level or above elective (*192.101 English for Academic Purposes for Speakers of Other Languages recommended*)
- 100-level or above elective (*consider prerequisite for 300-level elective*)
- 200-level or above elective (*110.279 Auditing or 110.289 Taxation recommended*)
- 200-level or above elective (*110.249 Accounting Info Systems recommended*)
- 300-level elective
