You and your colleagues may, however, require other documentation for your visit, which includes:

- temporary resident visas (http://www.cic.gc.ca/english/visit/apply-how.asp); and
- any additional items requested by Canada immigration authorities.

It is the responsibility of the traveler to ensure that they have the appropriate immigration documents for their visit. It is highly recommended that travelers contact Canadian immigration authorities directly to discuss their planned visit to Canada. To enter Canada travelers must provide Canadian immigration authorities with:

- a copy of this letter of invitation; and
- a valid passport (some rare exceptions may apply to this requirement, however; we strongly recommend that you have a valid passport).

Immigration Processing Times and Fees

Depending on one's citizenship, Temporary Resident Visas may be required to enter Canada (http://www.cic.gc.ca/english/visit/visas.asp). Processing fees are charged, however; rates may depend on the number of individuals who apply together, at the same place. Processing times for immigration documents can be quite lengthy. Please ensure you apply as early as possible.

Health Care and Travel Insurance

Travelers are responsible for obtaining appropriate medical and travel insurance for the duration of their stay in Canada, prior to coming to Canada.
